

2024 OIA Membership Renewal Frequently Asked Questions

How are my dues calculated?

- Dues amounts are based on the number of producers in your agency. Please affirm the number of producers that we have for your agency during the renewal process and update/adjust it if it has changed.
 - o Include all producers, regardless of W-2 or 1099 status. If your agency doesn't use a traditional producer model, add up the percent of time each employee spends quoting and placing business, and include one producer each time you reach 100 percent. For example, if three employees spend one-third of their time quoting and placing business, that equals one producer. Please note, you should have at least one producer per office location.

What percent of our OIA membership dues are deductible on our federal taxes?

• That is calculated at 94% given our non-profit status & that which is attributed to our advocacy efforts!

Do you accept online payments?

- To pay online, log in to ohioinsuranceagents.com, click on "Membership" select "Renew Your Membership" and "Agency Orders" - please note the online portal only accepts credit cards. EFT/e-check/ ACH payments would need to be phoned in

 - o 1% fee up to \$1,000 & then \$10 flat for anything over \$1,000 for ACH
 - o 3.5% fee applies for Credit Card

I received an invoice from PIA National, should I pay?

- As of 2019, we surrendered our PIA National charter in the state of Ohio. This was after extensive
 consideration of the challenges and opportunities that face IAs in the changing marketplace, and
 evaluation of the redundancy of services between the two national agents' organizations.
- Your OIA membership gets you membership in the Big I National. It has all of the same and more services available for your agency. For one fee, you get state and national membership.
- PIA National membership is separate from OIA membership

When are our dues actually due?

1/1/24 is the due date with a grace period officially ending 2/28/24.
